Campground Rental Agreement



1. Definitions:
 - 1.1. Campground
 - 1.1.1. Includes all numbered campsites, electrical and non-electrical, designated for camping with trailers or tents. Also includes the washroom and laundry facilities located nearby.
 - 1.2. Main Camp
 - 1.2.1. Includes the children, youth, adult, and family programs which are scheduled to run during the summer months, as well as the buildings and other structures in the northeast corner of the property, and any activity areas used by these programs including, but not limited to, Shooting Ranges, BMX course, fire pits, Low Ropes Course and Riding Corals.
2. Purpose and Mission Statement:

The GSBC Campground exists to provide families a pleasant, safe, family-oriented environment in which they can enjoy their summer camping. While in our campground, families are encouraged to participate in registered events and volunteer service.
3. Campground Rules and Policies
 - 3.1. Each family is asked to take the following considerations as a guideline for their behaviour while camping:
 - 3.1.1. Please respect the natural environment as well as any structures belonging to Good Spirit Bible Camp. Vandalism is not tolerated.
 - 3.1.2. There is to be no alcohol or non-medicinal drugs brought on camp property or consumed while in residence.
 - 3.1.3. There is to be no smoking in or around any of the camp facilities. The designated area for smoking in the campgrounds is around your own fire pit.
 - 3.2 Quiet time is 11:00 pm each night. In addition, when the Main Camp is running summer programs, campfires are scheduled to take place nightly anywhere between 8:00 pm and 11:00 pm. Please be aware of the Camp programs in operation and exhibit extra sensitivity around the campfire pit during these times.
 - 3.3 Remember that the overall camp experience of each participant in our Main Camp programs is of the utmost importance. Please attempt to limit your contact with these programs if not a participant so that their personal camp experience may be preserved. We ask that an extra effort be made if you are a parent or relative of one of our participants. Abuse in any of these areas may lead to removal of that participant from the program.
 - 3.4 Do not enter any of the main camp areas while programs are in session. Use of any of the main camp facilities or program equipment is prohibited. Please use the main gate for access to and from the campgrounds and the Provincial Park rather than walking through the main camp.
 - 3.5 Only one camping unit (tent trailer, camper, camper-truck/van, camping trailer, or motor home) is allowed per campsite. Only one tent is allowed per site for accommodating dependant children and one screened tent may be allowed.
 - 3.6 Grey water sewage must be contained and disposed of at disposal sites. Disposal of grey water/sewage on the ground is prohibited.

- 3.7 Fires are allowed in the fire rings only. Propane or other non-wood burning portable barbeques are acceptable. Any fire bans implemented by the provincial park will be observed and enforced.
- 3.8 Power generators may be allowed provided the noise produced is at a minimal level. Acceptability will be determined by the Camp Director or the Campground Committee. The camp may restrict hours of use as deemed appropriate.
- 3.9 ALL PETS must be kept LEASHED or in camper at all times. There are no pets allowed in camp buildings. Owners are responsible for proper clean up and disposal of pet waste. Dogs can only be left leashed outside in the campsite if owners are present.
- 3.10 Only two vehicles (including watercraft) are allowed per campsite as space permits. Visitors may use the parking lot at the south end of the game field provided there is room available. Be sensitive to other campers and the space of their campsites. Do not block any roads, park in front of the washroom facility, park in campsites other than your own, or park on the game field with any of your vehicles.
- 3.11 Full time campers are allowed to make improvements to their campsites. The following are guidelines with regards to improvements:
- 3.11.1 Campers are not allowed to remove any living trees unless permission has been granted by the Camp Director or the Campground Committee.
 - 3.11.2 Only one building is allowed to be constructed on a campsite. The building can be no larger than 8' x 10' and no more than 8' high. The building must be constructed in such a way that it can be moved easily. The camper is responsible for the removal of the building.
- 3.12 As stated in the mission statement, all families wishing to camp at the GSBC Campground must show some interest in the main camp's ministry. This can be shown by registered participation, or in material, financial, or spiritual ways.
- 3.13 These are not public campgrounds. Because you are on private property, Good Spirit Bible Camp reserves the right to reject access to, or remove any camper and their camping gear (tents and trailers included) from the campgrounds without cause.
- 3.14 A campsite rental agreement must be signed by each renter and will be kept on file at the camp office.
- 3.15 Each camper is responsible for informing all family members and visitors of the campground regulations.
- 3.16 Each camper is responsible to obtain their own camper and vehicle insurance.

Remember that it is a privilege to be camping on Good Spirit Bible Camp's private property, and as such, we ask that you adhere to the standards of behaviour held by the camp. Thank you.
